IN 2020 JFSA PROVIDED FINANCIAL ASSISTANCE TO MORE THAN 1000 HOUSEHOLDS. IN ADDITION TO DIRECT FINANCIAL ASSISTANCE, JFSA OFFERS A FOOD PANTRY TO THOSE FACING FOOD INSECURITY.
